The Clayton County Library System contributes to the community and its citizens by offering services that meet their informational, educational, and leisure interests. There are six libraries located in the County with 2,992 library programs and over 1/2 million books. The Clayton County Library System is a member of GALILEO, Georgia's virtual library of full-text articles, e-books, journals, educational videos, and more.

The County's seventh library features a Maker's Space, a creative, collaborative space with tools and equipment for electronics, 3D printing, woodworking, art, design, classes, and events. Open to children, adults, and entrepreneurs, the space features enclosed and individual meeting rooms for 40 people. The furniture, fixtures, and equipment are flexibly mobile for ease of collaboration and include charging stations for phones, laptops, and personal electronic devices.

## District 1

Clayton County Senior Services Department enhances the quality of life and dignity for elderly citizens by assessing and expanding an in-home delivery model. Programs emphasize health and wellness, including screenings, exercise programs, nutrition, education, and field trips.

Located on Anvil Block Road in Ellenwood, the Sonna Singleton Gregory Senior Center is the fourth SPLOST-funded senior center in Clayton County. Expanded features include a lap swimming pool, state-of-the-art fitness center, a community garden, and a large multipurpose space.

## Forest Park Branch Library District 2

Sensitively designed to preserve a cluster of mature hardwood trees, this library in suburban Forest Park integrates with nature. The glass west wall encircles the trees, whose leaves and branches diffuse the natural light entering the building. With the circulation desk at its center and the general connection and children's library on either side, the facility is easy to navigate. Visitors can come and go with ease, but the views and the sunlit interiors will entice many to sit and enjoy a book.

## Animal Control Adoption Center District 1

The Animal Control Adoption Center located on Anvil Block Road opened in November 2016. This 12,018 square-foot facility provides care for homeless pets, pet adoption services, and enforcement of the animal control laws in Clayton County. Designed with pet adoption in mind, the facility can house 178 animals, features a separate dog and cat area, and has an inside bonding room and a fenced-in outside area for adopters to romp and roam with their new furry families. The center is equipped for field operations and has a surgical suite to quickly care for incoming animals by a full-time, on-staff veterinarian.

## Animal Control Center Headquarters District 4

In 2017, the original Animal Control Center headquarters located in Jonesboro was renovated to improve the standard of care for animals in our county shelter. Inside renovations included climate-controlled kennels, floor sealant to prevent the spread of disease, and a grooming area. The expansion of the outdoor space added shade coverings, awnings, and a greenspace for adopters to meet and play with their new pets.

This facility houses EMS for the emergency operations, management, and mitigation of large-scale incidents and disasters. It also includes a fitness center for the health and wellness of CCFES personnel.

## Lake Spivey Trail System District 4

The Lake Spivey Trail System features four extraordinary bridges, two across lakes, one over a ravine on a golf course, and one over the entry into the International Park. This trail connects the J. Charley Griswell Senior Center to the new Lake Spivey Recreation Center and several adjacent neighborhoods to park facilities. This relatively flat 5.4-mile trail is ideal for recreational and natural enjoyment of the outdoors.

The environmental benefits of the green spaces include filtering pollutants from the air, providing shade that lowers temperatures (reducing soil erosion), and conserving our natural resources. The connected trails bring people together from all races, ages, income levels, and cultural backgrounds. These spaces allow citizens to engage in physical activity to improve their overall fitness and mental health. This connectedness improves the economy through tourism and civic engagement and preserves and restores open green space.

## Countywide Dog Parks All Districts

Located in the southern and eastern sectors of the County, our off-leash dog parks are spacious parks for dogs of all sizes to run and play. ## Tara Boulevard Sidewalk Summerwind Drive Flint Trail

Clayton County follows the Americans with Disabilities Act (ADA) guidelines to ensure that constructed sidewalks are to a set of standards that provides accessibility for the disabled, including the visually impaired, anyone in a wheelchair, or using crutches.

This project installed ADA compliant six-foot-wide concrete sidewalks, ramps, and concrete curbs along the west side of Tara Boulevard. Also installed were new roadway signage and storm drains.

## Panhandle Road Sidewalk District 3

This project installed a new five-foot-wide concrete sidewalk along Panhandle Road from McDonough Road (State Route 920) to Tara Road. Also installed were the Americans with Disabilities Act (ADA) compliant ramps, concrete curbs, gutters, new roadway signage, pavement markings, and improvements to storm drains.

# Widening and Reconstruction of Flint River Road District 3

The project widened and re-constructed Flint River Road from the existing two-lane facility to a three-lane facility with a continuous center turn lane beginning at Glenwoods Drive and ending east of Kendrick Road. The total project length was 1.13 miles.

## Mundy's Mill Culvert Extension/Shoulder Improvement District 3

The project extended the existing ten-foot by eight-foot triple barrel concrete box culvert at Swamp Creek to improve the roadside safety of Mundy's Mill Road. The roadway shoulders and embankment slopes were widened to the clear zone as defined by the American Association of State Highways and Transportation Officials.

# Widening and Reconstruction of Anvil Block Road District 1

Anvil Block Road was widened and reconstructed from Grant Road to Allen Drive at the Clayton/Henry County line. The portion of Anvil Block Road from Grant Road to Bouldercrest Road (project length of 0.46 miles) is a four-lane facility with a raised concrete median. The portion of Anvil Block Road from Bouldercrest Road to Allen Drive (project length of 1.34 miles) transitioned to a three-lane facility with a center turn lane. The total length of this project is 1.80 miles.

## Widening and Reconstruction of Godby Road District 2

Godby Road was widened and reconstructed from two lanes to four lanes. A raised concrete median was installed beginning at the Fulton County / Clayton County line and ending just east of the Godby Road and State Route 314 / West Fayetteville Road intersection. The total project length was 0.68 miles.

# State Route 138 Right-Turn Lane Construction at Lake Ridge Parkway - District 1

A 12-foot wide right-turn lane was installed along the southern side of State Route 138 between Shannon Oak Drive and Lake Ridge Parkway. A five-foot-wide concrete sidewalk parallel to the right-turn lane on the southern side of State Route 138 was also added.
